

### Website and Mobile App Terms and Conditions

Important to note: Your use of the Website and Mobile App is subject to these Website and Mobile App Terms and Conditions, as amended from time to time. You must read these Terms and Conditions carefully before using this Website and Mobile App as your continued use of this Website and Mobile App will signify that you have accepted them.

Pay special attention to parts in bold as they bear consequences to you using our Website and Mobile App.

Introduction

- 1. Whether you are a guest or a registered Participant, these Terms and Conditions will apply to you. The use of our Website and Mobile App includes assessing, browsing, linking or downloading any information made available on our Website and Mobile App and using any of our services made available on our Website and Mobile App.
- 2. ITHUBA UGANDA LIMITED, being the official Uganda National Lottery Operator in Uganda, brings you, the Participant, a range of various Uganda National Lottery games that can be purchased from our authorised Retailers, via www.nationallottery.go.ug and other digital platforms, such as the internet and cellular technology in accordance with these Terms and Conditions. These Terms and Conditions shall be read together with all applicable Ugandan legislations, such as, inter alia, the Data Protection and Privacy Act of 2019, Electronic Transactions Act of 2011; Anti-Money Laundering Act of 2013, Lotteries and Gaming Act 2016 ("the Act"), each Uganda National Lottery game rules and regulations (the "Rules") and the General terms and conditions applicable to each Uganda National Lottery game, in force from time to time (collectively referred to as the "T's & C's"). These T's & C's constitute the entire agreement between you and ITHUBA UGANDA LIMITED in respect to the use of the Website and Mobile App, services and its content.
- 3. If these Terms and Conditions (or any document referred to therein) or the services provided and/or made available on the Website and Mobile App are regulated by or subject to

the Consumer Protection Act, as may be amended from time to time, it is not intended that any provision of these Terms and Conditions contravene any provision of the Consumer Protection Act. Therefore, all provisions of these Terms and Conditions must be treated as being qualified, to the extent necessary, to ensure that the provisions of the Consumer Protection Act are complied with.

- 4. For the purposes of obtaining information on the Uganda National Lottery and ITHUBA UGANDA LIMITED in terms of Electronic Transaction Act,2011 and the (the Access to Information Act) please see our contact details on the website and mobile App at www.nationallottery.go.ug
- 5. The Rules and the general terms and conditions applicable to each Uganda National Lottery game are available on www.nationallottery.go.ug (the "Website" or "Site") and Mobile App and it is important that you understand that when you participate in the Uganda National Lottery, you concordantly agree to abide by the T's & C's. Each Participant needs to accept the T's & C's, failing which he/she may not register and/or use any of the services provided by ITHUBA UGANDA LIMITED.
- 6. To view the Act and Regulations pertain to the National Lottery, please visit the live link: https://lgrb.go.ug/acts
- 7. You may not access the Website and Mobile App or use any of our services if you are younger than 18 years old and/or do not have legal capacity to conclude a legally binding contracts.
- 8. The Website and Mobile App is not targeted at children under the age of 18. We will not knowingly collect information from persons in this age group. We encourage parents to talk to their children about the use of the Internet and information they disclose on the websites. Furthermore, we encourage parents to be the ones that use our Website (being of and above 18 years).
- 9. The T's & C's constitute the entire agreement between you and ITHUBA UGANDA LIMITED with respect to the use of the Website and Mobile App, services and its content. By accessing our Website and Mobile App or using our services, you are regarded as having read and agreed to these T's & C's.

## **Exclusion of Liability/Disclaimer**

- 10. ITHUBA UGANDA LIMITED does not warrant the accuracy, completeness or usefulness of any information contained on the Website and Mobile App. ITHUBA UGANDA LIMITED does not warrant that the functions contained in the materials available through the Website and Mobile App will be uninterrupted or error-free, that defects will be corrected, or that the materials, Website and Mobile App or the server/s that makes them available are free of viruses or other harmful components. # **Uganda National Lottery Game Rules**

- 15. In addition to the T's & C's, you must be at least 18 years of age to purchase any Uganda National Lottery game and to qualify for any prize resulting therefrom.
- 16. In order to participate in the Uganda National Lottery game, you may purchase a ticket at any of our authorized retail outlets, available alternate channels, or you can register on www.nationallottery.go.ug or use our Mobile App.

### **Online Play - Registration**

- 17. To register online, we require you to provide the following information:
- First Name;
- Surname;
- National Identity Number;
- Valid Cell phone number;
- Valid Email Adress
- Residential Adress
- 18. You agree to provide true, accurate, current and complete information about yourself as prompted by the registration process. ITHUBA UGANDA LIMITED will therefore place reliance on the information that you have provided as true, accurate, current and correct. As a result, it is your responsibility to ensure that you maintain and promptly update your information, from time to time, to keep it true, accurate, current and complete, and to acquaint yourself and to comply with the relevant laws and Rules for playing the Uganda National Lottery games, in force from time to time. ITHUBA UGANDA LIMITED reserves the right to verify the eligibility of all entrants. Should you provide any information that is untrue, inaccurate, not current or incomplete, or ITHUBA UGANDA LIMITED suspects that such information is untrue, inaccurate, not current or incomplete, ITHUBA UGANDA LIMITED will in its sole discretion exercise its right to remove and discard any information gathered from you, and refuse you any and/or all current or future use of the Website and Mobile App (or any portion thereof). Any person supplying false or misleading information, including but not limited to, telephone number, identity number, fax, email, postal or street address, name, bank information or the like, will forfeit any prize/s won through the Uganda National Lottery without notification. All ITHUBA UGANDA LIMITED's rights are hereby strictly reserved.

- 19. Participants are only permitted one account and are specifically prohibited from opening multiple accounts in the name of or on behalf of other persons.
- 20. Personal details required to be provided during the registration process will be kept confidential. However, by accepting this T's & C's you hereby consent and/or authorize ITHUBA UGANDA LIMITED and/or any of its authorized Partners and/or affiliated entities within the ITHUBA Group to share your personal information for the purpose of fulfilling the purchase of the lottery game/s, and to process any lottery winnings you might have wont. Furthermore, you consent and authorize ITHUBA UGANDA LIMITED to share, process, and store your personal information across borders with its affiliated ICT provider, namely Paytronix Systems (Pty) Ltd which is located within the borders of the Republic of South Africa. By providing personal information, you agree that we may electronically store, process and use the information for purposes stated therein when you opt-in to receive any communication from us.
- 21. When you access the Website or Mobile App, certain usage details may be automatically collected and recorded by us from your system by using different types of tracking technology. We may use the information to monitor the aggregate website and Mobile App usage metrics such as the total number of visitors and pages accessed as well as track your entries, submissions and status in any promotions or other activities in connection with your usage of the Website and Mobile App. ITHUBA UGANDA LIMITED may, in its absolute and sole discretion, refuse or cancel your registration or refuse to permit any further participation in www.nationallottery.go.ug for any reason whatsoever.

## Online Play - E-wallet users (Participants)

- 22. Once you have successfully registered your profile on the Website or Mobile App, your 'virtual wallet' (e-wallet) will be created in which you will store your Uganda National Lottery game funds.
- 23. You will be required to create a Personal Identification Number (PIN) in order to access your profile and the Uganda National Lottery e-wallet. You will be required to deposit your money into your e-wallet as per the details provided on our Website or our Mobile App. You are accountable for always safeguarding the confidentiality of your PIN, and ITHUBA UGANDA LIMITED shall not, under any circumstance, assume responsibility or liability for any unauthorized use of your PIN.
- 24. You are responsible for ensuring that we have your correct cell phone number and email address. ITHUBA UGANDA LIMITED will not be held responsible if an SMS or email is sent to the wrong number or address that you have supplied on your account.

- 25. The funds loaded will be credited to your e-wallet thereafter. No Uganda National Lottery game entries will be purchased and/or processed unless there are sufficient funds in your e-wallet.
- 26. ITHUBA UGANDA LIMITED will use a service provider (third party) for the processing of funds in and out of your e-wallet. ITHUBA UGANDA LIMITED is not a registered financial service provider and shall not be responsible in any way or manner for any incorrect allocation of funds and the like that you may suffer as a result. You will only be permitted to play the Uganda National Lottery games once confirmation has been received from the relevant financial institution and/or the Payment Provider/s that funds have been successfully transferred into your virtual wallet.
- 27. Always ensure that you have sufficient funds in your virtual wallet to play any of the available Uganda National Lottery games. Should you not have sufficient funds in your e-wallet, we reserve the right to deny you the right to participate in any of the Uganda National Lottery game/s.
- 28. A confirmation E-wallet inbox message will be sent to your account inbox for each transaction/s completed at no charge. Kindly be advised that in the event you do not receive the confirmation E-wallet inbox message due to technical malfunctions or system unavailability and the likes, your transaction will be deemed invalid (even if your account has been debited). Nevertheless, any debits made to your virtual account will be promptly reversed as soon as reasonably feasible.
- 29. There may be other websites that are linked on our Website. Links used to access other third-party websites are subject to their own terms and conditions. When using our e- wallet service to purchase any of our Uganda National Lottery games, you agree and consent that we may also electronically collect, store and use, without limitation, your name, surname, birth date, identity number, gender, country of residence, nationality, email address and mobile number. When using the services of a third party to make deposits into your e- wallet, you agree to abide by the terms and conditions of that service provider as may be applicable. Any content, information and materials on any third-party websites are provided "as is". Your use of such third-party websites is entirely at your own risk and we are not responsible to you for such use in any manner whatsoever. To the extent permissible in law, ITHUBA UGANDA LIMITED will not be responsible for any loss, expense, claim or damage, whether direct, indirect, consequential, and arising from your use of such third party websites or your reliance on any information provided on such third party websites.

## **Online Play - General**

30. By using the Website or Mobile App to participate in the Uganda National Lottery game/s, you understand, agree and confirm that your purchased entries into a particular

Draw/s for specified amount/s and particular date/s constitutes a binding agreement in law with ITHUBA UGANDA LIMITED.

- 31. You may use our Website or Mobile App only for lawful purposes only.
- 32. Tickets purchased using the Mobile App and/or the Website shall not be cancellable.
- 33. Should there be an error of any kind when using our Website or Mobile App, you are encouraged to contact our Call Centre (details on our Website, Mobile App). ITHUBA UGANDA LIMITED may refund an e-wallet account, should there be any error of a technical nature; provided however that there was no purchase of the ticket into our Uganda National Lottery games. ITHUBA UGANDA LIMITED, however, reserves the right to investigate any query or complaint made in this regard and whether or not to refund an e-wallet account.
- 34. To the extent that ITHUBA UGANDA LIMITED offers participation in competitions or promotions, the Terms and Conditions pertaining to those competitions and promotions will be available on the Website and Mobile App. Those Terms and Conditions shall be read together with these T's & C's. By entering or participating in the relevant competition or promotion, you agree to be bound by those relevant terms and conditions, including these Terms and Condition. Should there be any inconsistencies and contradictions between those Promotional Terms and Conditions and these T's & C's, these T's & C's shall prevail. Notwithstanding any specific terms and conditions, we specifically retain the right, at any time and without notice, to remove, alter or add to competitions or promotions on the Website without any liability to you.
- 35. When playing any Uganda National Lottery games, you do so with the acceptance and understanding that you are playing responsibly. Excessive play is prohibited and will be monitored. The maximum playing value per ticket for all Uganda National Lottery games available via the Website and Mobile App is UGX 400,000. This maximum value can be adjusted from time to time.
- 36. It is your sole responsibility to ensure that all the details shown on the relevant electronic page (internet or cell phone) are confirmed to be true and correct before proceeding to confirm your purchase of any Uganda National Lottery game.

#### **Online Withdrawal**

You have 2 options to withdraw the funds from your e-wallet: -

- Transfer into a Ugandan bank account; and/ or
- Transfer into a Mobile Money Wallet.

- 37. You will be charged a transaction fee for normal bank transfers and/or Mobile Money Wallet transfers.
- It will be necessary for you to furnish ITHUBA UGANDA LIMITED with a valid copy of identity details (i.e. a valid NIN document/Passport Number).
- Payment may take up to 2 (two) working days from receipt of all required documentation.
- Funds may reflect within 72 (seventy-two) hours of transfer, depending on the bank's rules, or the Mobile Money rules.
- 39. You are responsible for maintaining the confidentiality of your password and are fully responsible for all activities that occur under your password and the virtual wallet.
- 40. You acknowledge that if a third party (including any members of a syndicate on whose behalf you might act) becomes aware of your password, such person will have access to all of the services and features associated with the operation of your e-wallet.
- 41. ITHUBA UGANDA LIMITED will, under any circumstance, not be held liable for any loss, claim and/or damage you may suffer or incur, howsoever arising, including but not limited, to, or as a result of the use (authorised or unauthorised) of your password and/or Ewallet.
- 42. You indemnify ITHUBA UGANDA LIMITED, the NLGRB and their respective Representatives against any loss, expense, claim or damage of whatsoever nature and howsoever arising from the use of the Website, or arising from any delay or failure by ITHUBA UGANDA LIMITED to send an email or SMS to you. ITHUBA UGANDA LIMITED makes no representation or warranty, whether express or implied, as to the operation and functionality of the Website.

## **Purchasing Times**

On any draw day for LOTTO, PowerBall and DAILY LOTTO the closing time is 20h30.

- 43. You can only buy LOTTO boards during the times prescribed below:
- On draw days (Wednesdays & Saturdays) 06h00 to 20h30.
- On Sunday between 06h00 and 17h30.
- On other days (Monday, Tuesday, Thursday and Friday) between 06h00 and 22h30. LOTTO draw days are Wednesday & Saturdays.

- 44. You can only buy PowerBall boards during the times prescribed
- On draw days (Tuesday & Fridays) 06h00 to 20h30.
- On Sundays between 06h00 and 17h30
- On other days (Monday, Tuesday, Thursday, Friday) 06h00 and 22h30
- PowerBall draw days are Tuesday and Friday
- 45. SPORTSTAKE 10 fixture lists are offered twice a week as per the below:
- Midweek Fixture List opens Sundays, 06h00 until 30minutes before the start of the first game
- Midweek Fixture results are published on Friday mornings
- Weekend Fixture List opens Thursday, 06h00 until 30 minutes before the start of the first game
- Weekend Fixture results are published Monday mornings
- SPORTSTAKE 10 fixture results are considered as the final score after 90 minutes of play or after extra time where applicable, however these excludes penalty shoot-out.
- 47. You may purchase DAILY LOTTO daily, except on Christmas Day unless otherwise determined by ITHUBA UGANDA LIMITED during the times on a daily basis between 06h00 to 20h30. DAILY LOTTO draw days are held daily at 21h00.
- 48. For the EAZiWIN and SPIN4CASH games please refer to the Rules pertaining to the game.

#### **Intellectual Property**

- 50. You acknowledge and agree that the Website and any necessary software used in connection with the provision of the Website contain proprietary and confidential information that is protected by applicable intellectual property and other laws.
- 51. You further acknowledge and agree that all trademarks, logos and content contained in advertisements or information presented to you through our Website whether protected or not by copyrights, trademarks, service marks, patents or other proprietary rights and laws shall not be used by you. Except as expressly authorized by ITHUBA UGANDA LIMITED or the NLGRB you agree not to modify, use, rent, lease, loan, sell, distribute or create derivative works based on the Website, in whole or in part.

- 52. The Uganda National Lottery trademarks, logos and product names are the intellectual property and trademarks of the ITHUBA UGANDA LIMITED and the NLGRB (the "Uganda National Lottery Marks"). Without ITHUBA UGANDA LIMITED's or the NLGRB's prior written permission, you agree not to refer to, copy, distribute, display or use in any manner, the Uganda National Lottery Marks.
- 53. The ITHUBA UGANDA LIMITED logos and slogans, and product and service names are the intellectual property and trademarks of ITHUBA UGANDA LIMITED (the "ITHUBA UGANDA LIMITED Marks"). Without ITHUBA UGANDA LIMITED's prior written permission, you agree not to refer to, copy, distribute, display or use in any manner, the ITHUBA UGANDA LIMITED Marks.
- 54. For the avoidance of doubt, the rest of the content of this Website which includes, but is not limited to, the text, graphics, icons, designs, colours, lottery results, layout are the intellectual property of ITHUBA UGANDA LIMITED and its associates. All the intellectual property rights referred to herein are governed by the Ugandan and international intellectual property laws.
- 55. In the case of any disputes regarding these Terms and Conditions, the decision of ITHUBA UGANDA LIMITED will be final and binding, and no further correspondence will be entered into.
- 56. You agree not to circumvent, disable or otherwise interfere with security related features of the Website or features that prevent or restrict use or copying of any content or enforce limitations on the use of the website or its content. All rights are herein reserved by ITHUBA UGANDA LIMITED.
- 57. Any reproduction modification, creation or derivative works from or redistribution of the Website and Mobile App its content is expressly prohibited. Copying or reproducing the Website or Mobile App or any of its content or any portion thereof to any other server or location for further reproduction or redistribution is expressly prohibited.

#### **Termination**

- 58. These Terms and Conditions apply to the use of the Uganda National Lottery Website, Mobile App (including the wallet) until your online access is terminated by you or ITHUBA UGANDA LIMITED.
- 59. You may terminate these Terms and Conditions at any time by ceasing to use the Website, Mobile App or the content contained therein and destroying all materials received or downloaded from the Website and Mobile App.

- 60. ITHUBA UGANDA LIMITED reserves the right to delete accounts (i.e. your profile and your virtual wallet) that are inactive for a continuous period of 6 (six) months (or such period as ITHUBA UGANDA LIMITED may determine) with immediate effect.
- 61. ITHUBA UGANDA LIMITED reserves the right to suspend or close your virtual wallet at any time on notice and the balance of such virtual wallet funds MAYBE be remitted to you unless ITHUBA UGANDA LIMITED is required to do otherwise by law. ITHUBA UGANDA LIMITED reserves the right, at any time, and/or from time to time, to modify or discontinue temporarily or permanently, www.ithubauganda.co.ug/ (or any part thereof) on notice to Uganda National Lottery players via our Website.
- 62. Neither ITHUBA UGANDA LIMITED, the NLGRB nor any of their respective Representatives shall be held liable to you or to any third party for any modification, suspension or discontinuance of the Website and Mobile App.
- 63. Upon termination of your online play registration and/or the subsequent close of your account, you consent to our retention of the information we have already collected from you for record-keeping purposes only and in accordance with applicable law.
- 64. The termination of any contract created by these Terms and Conditions will be without prejudice to any other rights or remedies that you or we may be entitled to under the agreement or at law, and will not affect any of our or your accrued rights or liabilities nor the coming into or continuance in force of any provision of these Terms and Conditions which is expressly or by implication intended to come into or continue in force on or after such termination.

## General

- 65. Prize winners at www.nationallottery.go.ug agree that, if and to the extent that ITHUBA UGANDA LIMITED is legally obliged to provide a third party with details of any prize claimed by or on behalf of, or paid to the prize winner, ITHUBA UGANDA LIMITED shall be entitled to do so.
- 66. The following representations and warranties are material to ITHUBA UGANDA LIMITED and have been relied upon by ITHUBA UGANDA LIMITED to accept your registration and entry into the Uganda National Lottery game/s:
- •You have read and fully understand, and will continue to understand and comply with the T's & C's in which you purchase the Uganda National Lottery game through the Website;
- You are at least 18 years of age;

- •You have the necessary legal capacity to purchase Uganda National Lottery game ticket and each purchase you make, when accepted, will be legally binding and enforceable against you;
- You will play responsibly and not excessively according to the set limitations; and
- •You consent to your personal information being shared, process and stored across the board of the Republic of Uganda
- 67. You may opt- to receive communication via email or SMS. Contrary to the provisions of clause 28 above, these rates are subject to change from time to time at the sole discretion of ITHUBA UGANDA LIMITED. Payment for tickets must be completed before the purchase cut off time for the ticket to be valid and entered for the selected draw. You are responsible to ensure that the Uganda National Lottery game ticket purchases are completed on time for a draw.
- 68. It is your responsibility to check and ensure that your Uganda National Lottery game ticket has been entered into the selected draw should you fail to receive a confirmatory sms or message. If no valid ticket is received then the entry into that draw is not valid.
- 69. All fees incurred for the transfer of winnings, including but not limited to bank fees for opening a new bank account or a cash deposit fee, are for your account. Likewise bank charges applied by your bank pertaining to any purchase made via your virtual wallet will be for your account.
- 70. You agree not to reproduce, duplicate, copy, sell, resell or exploit for any commercial purposes, any portion of the Website and Mobile App or any service provided therein.
- 71. The instructions on how to register and use the Website and Mobile App service forms part of these Terms and Conditions.
- 72. The failure of ITHUBA UGANDA LIMITED to exercise or enforce any right or provision of these Terms and Conditions shall not constitute a waiver of any such right or provision to do so at any time and in any appropriate forum.
- 73. Save as otherwise provided, no provision of these Terms and Conditions constitutes a stipulation for the benefit of a third person, which if accepted by the person, would bind any party in favour of that person.
- 74. You may not cede, assign or otherwise transfer your rights and obligations in terms of these Terms and Conditions to any third party.

- 75. Whilst we take all reasonable steps and precautions to ensure the accuracy of all the content we make available on our Website and Mobile App, the content provided is intended for general information purposes only. As such, the provisions as contained within the Website and Mobile App are provided "as is" and without warranties of any kind whatsoever either expressed or implied.
